1. Fees, Withdrawal and Refund

I understand that if I should decide to withdraw from the Program, at any time or for any reason, or if I should be terminated from the Program at the sole discretion of Earlham or its representative, the applicable withdrawal refund and fee information is outlined in the acceptance letter that I received when I was accepted into the Program, and I agree to the listed refund and fee amounts.

2. Dismissal

I understand that the Japan Study Program Director, in consultation with the on-site Resident Director, Program Associate, and International Programs Office at Earlham College, has the authority to establish expectations for operation of the Program, and I agree to honor and abide by those expectations. Such expectations include, but are not limited to:

- i) satisfactory academic work prior to and during the Program;
- ii) ability to meet the financial obligations of the Program;
- iii) willingness to be a responsible and cooperative group member;
- iv) conformity to Program rules and expectations;
- v) upholding laws and regulations of any jurisdiction through and to which I travel in connection with the Program and during breaks;
- vi) good health that promotes effective participation;
- vii) disclosure of material information requested by the Program; and
- viii) appropriate conduct in the host community, including housing accommodations, social and cultural activities,
- ix) expectations regarding health and welfare, and field study placements.
- x) I agree that my conduct which is potentially dangerous to the students or to others, such as the illegal use, possession, or transfer of drugs, or excessive alcohol consumption, may result, at the sole discretion of Japan Study, Earlham College or its representative, in my termination from the Program.
- xi) I understand that unsatisfactory academic work prior to departure, placement on disciplinary probation by the student's college, significant mental or physical health challenges, or unwillingness to follow Program rules and policies at any point during the Program may result, at the sole discretion of Japan Study, Earlham College or its representative, in my termination from the Program.

3. Consent to Disclose Complaints of Sexual Harassment and/or Sexual Violence I understand that Japan Study, as an Earlham College program, is subject to Title IX of the Education

Amendments of 1972 (a federal law that prohibits discrimination on the basis of sex in federally

funded educational programs), which requires, among other things, that Earlham respond to complaints of sexual harassment and/or sexual violence so that any hostile environment is eliminated.
